Junior Secretariat Assistant/Lower Division Clerk Grade Limited Departmental Competitive Examination, 2021 & 2022: Declaration of result of Paper-I for shortlisting of candidates for evaluation of APARs

Staff Selection Commission conducted Paper-I (Descriptive Paper) & Paper II (Computer Based Examination) of Junior Secretariat Assistant/ Lower Division Clerk Grade Limited Departmental Competitive Examination 2021 & 2022 on 04.03.2024 for the following Services/Cadres:-

- i. Railway Board Secretariat Clerical Service, Ministry of Railways;
- ii. Armed Forces Headquarters Clerical Service (AFHQ);
- iii. M/o External Affairs (Cadre Cell);
- iv. Central Passport Organization, M/o External Affairs;
- v. Farm Machinery Training and Testing Institute, D/o Agriculture and Farmers Welfare;
- vi. Forest Survey of India, M/o Environment, Forest & Climate Change;
- vii. Lal Bahadur Shastri National Academy of Administration (LBSNAA)

2. As per the Scheme of Examination, the Examination consisted of two Parts - Part-I comprising Paper-I (Written Examination) and Paper-II (Computer Based Examination), and Part-II (Evaluation of Record of Service). Only those candidates who qualify in Paper-I of Part-I would be considered for Evaluation of Record of Service.

3. The result of Paper-II of Part-I of the said examination was declared on 23.04.2024 wherein 895 candidates (326 for the year 2021, and 569 for the year 2022) were shortlisted for evaluation of Paper-I.

4. Based on the performance in Paper-I of the examination, 877 candidates (318 for the year 2021, and 559 for the year 2022) are shortlisted for the next stage of the examination i.e Part-II [Evaluation of Record of Service (APARs)].

5. The category-wise cut-off marks and the number of candidates qualifying for the Evaluation of Record of Service (APARs) are as follows:-

6. The list of the candidates is purely provisional and subject to their fulfilling all the eligibility conditions prescribed for the respective posts in the Notice of Examination.
